COMMUNITY CONCERNS

HELP AVOID / CORRECT THE FOLLOWING VIOLATIONS

- Inadequate lawn maintenance (overgrown lawns)
- Inadequate maintenance of home, fence, pool, or other visible structures on the property
- Improper storage of trash and/or unwanted Items on the front, side or behind the property
- Parking of vehicles in the front yard. Expired or no tags on vehicles and flat tires. Parking on street overnight when space is available in drive-way
- Storage of boats, trailers, and operating/nonoperating vehicles on the street, front, side and/or behind unfenced property
- Failure to clean up behind your pet and/or allowing pets to release themselves on a neighbor's property
- Improper control of pet(s) to include cats. Walking pets without a leash
- Improper supervision of children
- Violation of NTHA/City/County Speed Limits and Noise Ordinances
- Mosquito breeding sites (longstanding, dirty water in containers/pools).
